Axxanol™ A35CD-32 enhances corrosion protection during challenging conditions such as ocean shipments. The coating is non-staining and can be removed with most conventional alkaline cleaners or left on the surface.

When handling parts coated in a film of Axxanol™ A35CD-32, always wear clean gloves without lint or talc to keep metals free of corrosion and contaminants. Once the coating is dry, no additional personal protective equipment (PPE) is required.

Store in a cool (50° to 86°F / 10 to 30°C), dry place, and away from sunlight in a closed container for up to 2 years from the date of shipment. Do not allow the product to freeze. If separation is found upon freezing, warm up to room temperature and mix thoroughly before using.
