Fully dried Axxanol™ A35CD-7 coated parts are safe to handle without the need for a respirator, mask, or safety glasses. Although gloves are not necessary for safety, wearing clean gloves without lint or talc is highly recommended when handling the coated parts. This will prevent leaving contaminants or dirt from bare hands. Use ZERUST® Axxanol™ A35CD-7 to safely protect multimetal parts during shipment, storage, and work-in-progress.

Storage

Store in a cool, dry place and away from sunlight in the original packaging. Storage temperature should be kept between 0 – 95°F (-18 – 35°C) for up to 2 years from the date of shipment. Reseal or close the container cap after each use. The product will dry and thicken in an open container. If Axxanol™ A35CD-7 should accidentally freeze, move it to a location warm enough to thaw >50°F (10°C) and thoroughly mix the solution to ensure homogeneity.

*The theoretical coverage estimates, based on the stated wet film thicknesses (WFTs), should be used as a guide only. These estimates were generated based on internal lab measurements of product coating on flat, smooth 1010 steel stock. Actual coverage data will vary in actual use based on the method of application, type of equipment used, part geometry, surface roughness, drain-off time, drag-out rate, evaporative loss, etc.
